## LOVELYCLOUD'S CONTRACT for the transfer of the cat

(hereinafter referred to as the Cat)

Having agreed on the purchase and sale of the Cat in the Cattery, the Buyer and the Seller accept the following terms of the Contract (hereinafter referred to as the Contract)

- 1 The Contract is determined to be activated from the date the Buyer makes the transfer of the Deposit, or the date when the full payment for the Cat is transferred. The Contract is considered to be valid throughout the whole life of the purchased Cat.
- 2 Deposit is not refundable no matter of the reason why the Buyer decided not to buy the reserved Cat. The prepaid fee goes for the Cat maintenance, and in case the client changes his mind, the deposit is to be considered compensation for the loss of the Cattery's investment.

The deposit or full payment is refunded if the Seller refuses to transfer the Cat to the Buyer.

- 3 The Cat becomes the property of the Buyer after full payment. The full payment is required to be transferred no later than 2 weeks before the shipment of the Cat.
- 4 The upkeep of the already purchased Cat in the Cattery for more than 1 month is to be paid by the Buyer. The maximum upkeep of the purchased Cat in the Cattery is not more than 3 months or, by agreement at the time of purchase, no more than 6 months.
- 5 If the Buyer does not make the full payment for the cost of the Cat or does not take the Cat after the expiration of the above period, the Cattery has the right to sell the Cat to another Buyer.
- 6 All shipping expenses: transportation price (shipping in cargo or using a service of a courier), price of the health certificate, price of the carrier are paid by the Buyer. If the Cat is replaced for any reason by the Breeder/Seller all shipping expenses (transporting price, price of vet papers, price of the

carrier) are the sole responsibility of the Buyer (are at the Buyer's expense).

- 7 The Cat is clinically healthy at the time of shipment, which is confirmed by a veterinary check/inspection in the establishment of the State veterinary service before leaving the Breeder's house.
- 8 The Breeder/Seller is not responsible for any genetic deviations, which may be found out throughout the life of the purchased Cat.
- 9 The Cat is to be transferred via CFA terms. The quality of the breed of the purchased Cat is to be determined at the purchasing process. Afterwards the claims for the item and the Cat's exhibition career are considered to be inadmissible.
- 10 In case the purchased Cat shows sign of any ailment throughout the first 5 days after the Cat is received by the Buyer, and aforementioned ailments are proven to be reasonable by provided documents (veterinary certificate of the State signed by a licensed veterinary clinic), the Buyer has a right to raise a claim against the Cattery. The claims raise after that period are inadmissible.
- 11 The Buyer is to maintain the Cat in the clean and healthy environment, to provide the Cat with balanced food (which is to be preliminary discussed with the Breeder/Seller) and clean water. The Cat is not supposed to be held in a cage.
- 12 Under no circumstances, the Buyer is to be violent with the purchased Cat, or remove the Cat's claws.
- 13 The Buyer is to provide the purchased Cat with regular veterinary vaccination and examination. In order to protect the Cat's health, the Breeder/Seller prefers that the purchased Cat is NOT to be given any Leukemia or FIP inoculation.
- 14 No outside stud service is to be allowed to the Cat (nether the Cat under a lease, co-owned). Males are not to be used for stud service; females are not to go out for stud service. Only animals owned completely by the Buyer can be bred to said cat/or used to breed the said cat.
- 15 The Cat may be placed in another home as a pet, whether for sale or as a gift, only if the Cat is neutered before the Cat leaves the Buyer's home.
- 16 Under no circumstances will this Cat be sold, leased or given to any pet shop, research laboratory or similar facility.
- 17 The Breeder/Seller and the Buyer shall perform their obligations properly, in accordance with the requirements of this Contract. In case of disputes, the Breeder/Seller and the Buyer will take all measures to resolve them through negotiations. If the agreement is not reached through negotiations, all disputes, disagreements and conflicts arising in connection with the execution of this Contract, as well as in case of its violation will be resolved in the court of the city of Kursk of the Russian Federation.
  - 18 The Contract for the transfer of Cattery's Cat is final.
- 19 The concluded Contract in 2 copies is legal and is valid from the date it is signed by both the Sides. The Contract's Appendix has equal to the Contract's legal force and is a part of the signed Contract.
